# PAGE 2 Fisheries Update Submitted by Michael Preul, May 8, 2015

In 2015, a comprehensive fish survey will be performed on Lake Lucerne. Survey work will primarily focus on gamefish populations but will also include some panfish work. Surveys will begin after ice-out and continue through fall. Survey results will be used to determine the structure and function of the fish community in Lake Lucerne and to provide information for the decision-making and the future management of fish populations in the lake. Results will be compared to previously performed surveys on Lake Lucerne; the last comprehensive fish survey was performed in 2011. Survey work will be performed by the Sokaogon Chippewa Community (SCC) and Wisconsin Department of Natural Resources (WDNR) fisheries staffs with assistance from volunteers from the Lake Lucerne Advancement Association (LLAA). In addition, Lake Lucerne will be stocked with large fingerling walleye in fall 2015.

#### **Project update:**

Earlier this spring, a walleye adult population estimate was completed on Lake Lucerne using a combination of fyke netting and nighttime electrofishing and mark-recapture sampling protocols. The survey began immediately after ice-out (April 16) and was concluded on the night of April 23. Survey results indicate that the walleye population in Lake Lucerne is at a low level. The population estimate for walleye was 0.7 adult walleye/acre or 713 fish, which is a very similar level to 2006 and 2011 (0.6/acre for both). Long-term management goals for adult walleye in Lake Lucerne are 2-3 adults/acre. The largest walleye sampled was a 27.0-inch female. The most common-sized walleye sampled was a 15 inch male.

Other gamefish sampled during the survey included northern pike and smallmouth and largemouth bass. A population estimate was not performed on northern pike due to low catch. A total of 34 northern pike were sampled with a 33.3 inch female being the largest. Catch rates for smallmouth and largemouth bass were low as well, but all sampled bass were fin-clipped for bass population estimate to be completed later in the spring. Low catch rates for bass were expected as bass are not active early in the spring with cold water temperatures. Other fish species sampled included black crappie, black bullhead, rock bass, bluegill, pumpkinseed, yellow perch, and sucker.

#### **Future work:**

Between mid-May and mid-June, as water temperatures warm to desirable levels, a smallmouth and largemouth bass population estimate will be performed using a nighttime electrofishing and mark-recapture sampling protocols. A panfish survey will be performed in mid-late June using nighttime electrofishing. Two surveys targeting reproductive success of panfish and gamefish will be performed: mini-fyke net survey in late August and nighttime electrofishing in mid-September.

In early October 2015, Lake Lucerne will be stocked with approximately 10,000 large fingerling walleye. Lake Lucerne is a participant in the Wisconsin Walleye Initiative with stocking in odd-numbered years including 2013, 2015, and 2017. Stocked walleye will average 7 inches in length and be of excellent condition and quality. Walleye will be raised locally at the SCC – Mole Lake Fish Hatchery Pond Complex. The Tribe will also be responsible for stocking Roberts, Pickerel, and Crane Lakes in Forest County and Upper Post Lake in Langlade County. Visitors are welcome at the Tribal Fish Hatchery.

The board has received a quote for 3 aluminum 4'x4' signs in full color and installed for \$554 from Alpine Images in Crandon. #### Status of down spout/gutters and snow defenders. Down spout and snow defenders are completed. Total cost was \$465.

Future of the Clean Boat Clean Water Program (CBCW) was discussed. We did not receive a DNR CBCW Grant for 2015. Grant Coordinator Hermus noted that the competition is increasing and dollars are limited. There was no specific reason given beyond that. It was noted that we did receive a \$3,000 grant from the Mole Lake Tribe to be used for AIS Projects. Rick and Larry provided several options for the board to consider which would continue with a CBCW program at a reduced level. After much discussion, it was agreed to offer Todd Veeser the position at a reduced hourly rate of \$12/hour, with reduced weekly hours at 25, and less weeks (from 21 to 15), only operating from Labor Day to Memorial Day. The 25 hours will require that the landing be manned for 8 hours on Friday, Saturday and Sunday. If no volunteers are available, Todd must be present on those days. The board will also seek other funding opportunities which would allow the program to expand to include additional weeks. It would be hoped that we could start when fishing opening in early May. If the program continues, the port-a-potty is necessary, but with no funding, it was suggested that we consider buying one, then we would only have to pay to service it occasionally. Jack will check on options. There will be no placemats, can coolers, phone or mileage reimbursement to reduce costs. Wayne Daul moved, Rick Hermus seconded the motion to continue with the CBCW Program with the new parameters as discussed. The motion carried.

Clean-up Day, May 9th, 2015 - A general discussion was held. The newsletter will not be out by May 9th, so it was decided to put the Clean-up Day notice on the marquis by the building only.

#### CLEAN BOATS/CLEAN WATER AIS GRANT NOT AWARDED LAKE LUCERNE RECEIVED \$3,000 GRANT FROM MOLE LAKE TRIBE Submitted by Rick J. Hermus, Grant Coordinator

After several years of successful grants from the Wisconsin Department of Natural Resources, the Lake Lucerne Advancement Association did NOT receive a Clean Boat/Clean Water Aquatic Invasive Species Grant for 2015.

Apparently, there are many more lakes in Wisconsin applying for these grants, with tremendous competition for the available resources. There are other lakes around us that are first-time grant recipients in 2015, with much lower dollar values. Our past grants averaged around \$9,500.

On the positive side, Lake Lucerne did receive a \$3,000 grant from the Mole Lake Tribe (Sokaogon Chippewa Community) to be used for Aquatic Invasive Species monitoring. The Lake Lucerne Advancement Association is pleased to be working with Mike Preul, the fish biologist with the Mole Lake Tribe, on our fish surveys and population estimates (please see separate article in this newsletter). As some of you may know, Mike was instrumental in securing much higher walleye stocking resources for Lake Lucerne, and continues to closely monitor the walleye population through fyke netting and electrofishing surveys. The partnership we have built with the Mole Lake Tribe is offering many rewards for Lake Lucerne.

Because of the grant from the Mole Lake Tribe, the Lake Lucerne Advancement Association Board has decided to continue with the Clean Boat/Clean Water inspections at the boat landing and shoreline monitoring in the same manner as we have in the past. Although we will not have funding for some of the peripheral projects that the previous grant allowed for, the board believes boat inspections will continue to add value to our lake by reducing the opportunities for invasive species to enter our waterway. Also, you, the members, have found several invasive species along our shorelines over the past several years during your shoreline monitoring, which were all eradicated by the Wisconsin DNR staff before they could flourish. You have been very successful, and we can continue with that success.

Todd Veeser will continue as the Boat Landing Coordinator with a reduced role that fits our current grant budget. Based on the scaled back parameters and your continued support, the program can continue to be successful. Please contact Todd via email at veesert@gmail.com to volunteer. Also, please send your shoreline monitoring hours to Grant Coordinator Rick Hermus at rchermus@yahoo.com.

And finally, the Lake Lucerne Board is seeking other sources of funding for the program that will allow the Clean Boat/Clean Water program to include more of the parameters that the past WDNR grants allowed. Hopefully we will have more information by the June Membership Meeting.



#### Temperature Loggers in Lake Lucerne -Why are we doing this and what do we hope to learn? Submitted by Gretchen Hansen D.N.R.

Temperature is a major ecological factor in lakes, influencing nutrient cycling, algal blooms, and the growth rates, reproduction, distribution, and survival of fishes. Understanding how water temperature varies over space and time is critical for management of Wisconsin's water resources, yet very few temperature monitoring programs for lakes exist at the frequency required for most applications. For example, quantifying components of critical thermal habitat for fish, such as early season temperature variability, requires daily measurements and can be all but impossible using manually collected temperature observations. Automated sensors deployed in lakes continuously over the open water (ice-free) season can provide accurate, continuous, consistent water temperature data invaluable for meeting many monitoring and management objectives. To this end, we have deployed temperature loggers and required equipment to collect continuous water temperature data at the surface of 48 lakes throughout the state. These lakes span a gradient of location, size, and productivity so we can identify temperature patterns in different lake types. The majority of these lakes (31) are monitored by citizen volunteers, with an additional 17 lakes monitored by UW-Steven's Point



students. Sensors were deployed as soon as possible following ice-out, and volunteers will ensure the loggers remains in place throughout the ice-free season and collect them in the fall for data retrieval. The data collected as a part of this project will be imported into the statewide monitoring database. Additionally, temperature data will be used as a vital component for ongoing efforts to model current and future lake thermal profiles throughout the state in order to prioritize management of fish and water quality.
