

#### **NEW BOAT LANDING DOCK**

This summer, Lake Lucerne was blessed with the brand-new dock at the Boat Landing, courtesy of the Wisconsin DNR. It is a 24-foot roll in dock manufactured by American Dock in Florence. It replaces the old 16-foot wooden dock.

Dan Peters is the DNR contact in charge of our boat landing. Dan has been very helpful the last few years assisting with damage at the boat landing due to ice shoves, locating the new Clean Boat/Clean Water shed and other maintenance. He continues to advocate for additional improvements, and his efforts are very much appreciated.

#### LAKE LUCERNE FISH STICK PROJECT UPDATE

The LLAA Board approved moving forward with the proposal developed by the Fish Habitat Committee for creating multiple fish sticks along the shore of Lake Lucerne at our September 21 meeting. This project utilizes a grant provided by the Town of Lincoln and the Forest County Potawatomi Community, the assistance of our local DNR Fishery Team, and the generosity of Lake Lucerne property owners.

The goal is to promote our lake's fishery by restoring an element fishery researchers are finding to be important for a healthy fishery — the woody carbon of submerged trees in the near shore environment. This is where life begins for some fish species, as well as providing food sources and habitat within the littoral zone's cycle of life. The fish sticks will primarily be located in the shallower southern end of Lake Lucerne, but some can be established elsewhere along the shoreline.

This photo is a fish stick built a few years ago by the DNR's Fishery Biologist's Team in Keyes Lake, Florence County. A fish stick consists of 2-4 trees cabled to the shoreline and secured to the lake bottom with anchors and steel cables

#### **ELECTION CHANGES**

With the passage of the new LLAA Bylaws, there are new rules that govern the election and voting process.

- To be eligible to be a member of LLAA, an individual, family, business, organization must own property or reside within one mile of the Lake Lucerne at least one month a year.
- Your yearly dues must be paid before August 1st or on the date of Fun Days to be eligible to vote at the annual meeting. The Annual Meeting is in the vicinity of Labor Day weekend.
- Up to two individuals, who are members in good standing, may represent a family, business, or organization as eligible voters.

  Each of those to individuals may cast one vote on any question called to a vote.
- Absentee voting is allowed for election of board members only. Members wishing to vote for the Board by absentee ballot must request a ballot from the Secretary at least 10 days prior to the Annual Meeting. Specific procedures will be announced at the June Meeting.
- Nominations for open Board positions at the Annual Meeting will be done at the June Meeting. There will be no nominations for Board positions at the Annual Meeting. We will be voting on Vice President, Treasurer, board members Jim Wienser & Jack Kloss.

The new Bylaws have created several committees. The Election Committee is one of them. We are looking for members in good standing to serve on this committee. The committee implements and supervises the procedures for absentee voting and the collection and counting of ballots during elections.
